 - ❑ Criteria for deciding eligibility **Bonafide farmers of the command areas of the completed irrigation project/farmers having plot of land with sufficient water during dry months.**

1. Name of Scheme : Fertilizer Distribution Scheme

2. Duration of the Scheme : Continuing Scheme.

3. Objective of the Scheme : The Main objective of the scheme is to provide subsidy on cost of Fertilizer so as to help the farmers in procuring fertilizer at reasonable prices and to encourage them the use of the same for better yield of the crops. At the same time the scheme provides subsidy on transport of fertilizer so that the sources are made available at uniform rates in all the consuming areas of the state. With the growing awareness among the farmers of the state on use of fertilizers for better performance and higher yield of the crop, requirement of fertilizers is increasing year by year and with the increasing rise in prices of fertilizer especially decontrolled ones, the subsidy provides same relief to cushion the impact of the increase in price. Thus the subsidy has to a great extent helps to encourage the use of fertilizers by the farmers so as to maintain the fertility of the soil and they also benefit better performance and good yield of their crops.
