18.1 Frequently Asked Questions.

Seed & Soil Testing

- Where from we can buy flower and vegetable seedlings?
- You can buy these seedlings from Government Farm situated in the Fruit Garden Area.

- Where we can do our Seed Testing?
- You can do the Seed Testing in the Seed Testing Laboratory Shillong, located at Cleave Colony.

- Where we can do the Soil Testing?
- You can do the Soil Testing in the Soil Testing Laboratory of the Research Office, DLRSL Shillong.

- What is the procedure to apply for seed Testing and Soil Testing?
- You shall have to give a seed and soil sample to the concern Officer of the Seed & Soil Testing Lab for doing the test. Individually it is difficult to do. Normally seed & soil samples are collected from the farmers field to do the Test with the help of Field Officers of the Department.

- Where from we can buy Seeds, Fertilizers, Pesticides etc.?
- You could buy these from the District Agriculture Office of the respective District.

- What are the schemes implemented by the Department?
- Department is implementing various State Plan Scheme, and Central Sector Scheme.

Agronomy

1. Where do we get seed ?

Concerned DAO's Office of the District and S.D.A.O's Office of the Sub-Division.

2.What is a HYV ?

HYVs are those varieties of crops specifically developed for their high yield potential compared to the local varieties.

3.What is Hybrid Variety ?

Hybrid varieties are first generation Cross- bred (Fi) varieties with higher yield potential.

4.Can we keep the seeds of Hybrid Varieties for next years planting ?
